Complaint Description:

This complaint alleges that Julie Hsieh, a candidate for Mercer Island City Council, has failed to accurately and timely report the expenditure related to her campaign PO Box in Mercer Island in violation of RCW 42.17A.235. Per RCW 42.17A.235 and .240. A candidate that selects the Full Reporting option on their registration report is required to report contributions and expenditures to the PDC on Cash Receipts Monetary Contributions reports (C-3 reports) and Campaign Summary Receipts & Expenditures reports (C-4 reports) pursuant to RCW 42.17A.235 & RCW 42.17A.240. The due dates for these reports are based upon the election cycle, the candidate's election participation, and their financial activity.

Julie Hsieh's campaign registration lists a PO Box address (Attachment 1), yet there is no corresponding expenditure or in-kind contribution reported for this payment. This same PO Box address serves as the principal office, principal place of business, and mailing address for at least 5 of her family companies. Those 5 Texas companies are (Attachment 2):

- HSIEH INVESTMENTS WASHINGTON, LP
- HSIEH INVESTMENTS WASHINGTON MGMT, LLC
- HSIEH'S INVESTMENTS TEXAS, L.P.
- HSIEH'S INVESTMENTS, INC.
- HSIEH INVESTMENTS WASHINGTON II, LP

It remains unclear which company, or combination of companies, provided this in-kind contribution to her campaign.

What impact does the alleged violation(s) have on the public?

State law requires candidates that register under full reporting to submit regular reports of financial activity. The public has the right to know where the contributions to a candidate are coming from.
