<p><a href="#">Michael Fertakis</a> reported via the portal  <i>(Fri, 19 Sep 2025 at 3:09 PM)</i></p> <p>According to Peter's C3 report filed on 8/30/2025 he received a contribution from a Lukas Irwin. Lukas Irwin donated \$260, yet according to the C3 filing he did not disclose his address or his company as legally required, and Peter's campaign still deposited his contribution despite being required to disclose Lukas' address as well as his employer for contributions over \$250 (WAC 390-16-034).</p>
<b>What impact does the alleged violation(s) have on the public?</b>
By accepting an illegal contribution and failing to disclose his contributor's details as legally required, Peter Kwon is eroding the public's trust in our electoral system and going against the spirit of fairness in our election system.
