Melissa Wells Wed, 15 Oct 2025 at 2:11 PM The attached mailer was received by many local voters that was paid for by Ms. Fain's campaign. This appears to be one of the common mailers that gets wide distribution during a campaign. During the primary election, Ms. Fain sent several similar mailers to approximately 15,000 to 20,000 homes each at a cost of approximately \$17,000 to \$20,000. With higher turnout in the general election, the cost for this mailer could exceed the amount spent per mailer in the primary. Apparently, a large expenditure is not being reported on Ms. Fain's 21 Day C-4 report.
What impact does the alleged violation(s) have on the public?
The primary purpose of the public disclosure law is to provide voters with the means for becoming informed about the financing of political campaigns before the election.

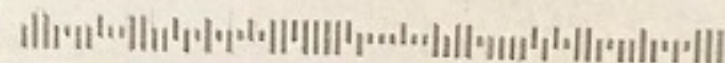
