I am submitting this complaint regarding potential violations of Washington State campaign finance and election laws by Neet Grewal, a candidate for [office, e.g., Kent City Council, Position 2.

1. Late or Missing Contribution Information

Several contributions reported by the Grewal campaign are missing required fields, including employer and city of employment information for donors. These omissions violate RCW 42.17A.240 and WAC 390-16-034. Screen captures from PDC website are attached as 1 pdc.jpg, 2 pdc.jpg, and 3 pdc.jpg.

2. Campaigning on Public Property

The candidate and campaign representatives have been observed campaigning on school district property, including setting up a table with campaign signs and materials during school events. This activity violates RCW 42.17A.555, which prohibits the use of public facilities to promote a campaign. This is confirmed in opening scenes of the video available in the instagram link below. Two screen shots from that video are in attached file 4 Screenshots from Instagram.jpeg. The first shows Neet Grewal's campaign material in front of the Kent School District Administration building with a partially occluded view of Candidate Grewal. The second image shows a complete view of Candidate Grewal.

3. Destruction of Opponent Campaign Signs

There are multiple reports and video evidence showing Neet Grewal and/or her campaign representatives removing or damaging campaign signs belonging to other candidates. Police report 25-09705 has been filed with the City of Kent Police Department regarding these problems, and the matter is under investigation. A video is attached to this report with the name 5 Video of sign distruction.mp4. Satwinder's sign is difficult to read in the dark video, but it is just below and to the right of the date and time stamp at the to of the image. You can clearly see a car coming into the image and stopping to remove and steal the sign.

Please investigate these violations to ensure compliance with Washington State campaign disclosure laws and uphold fair election practices.

What impact does the alleged violation(s) have on the public?

1. Late or Missing Contribution Information

This undermines the transparency which the PDC was set up to provide.

2. Campaigning on Public Property

This gives the impression to the public that Neet Grewal is somehow officially endorsed by the school district.

3. Destruction of Opponent Campaign Signs

This creates an unfair environment because it may appear that one candidate has more support simply because they have destroyed the other candidate's campaign signs.
