Dear Mr. Blackhorn:

Thank you for the opportunity to respond to the September 1, 2017 letter of Walter Smith making two allegations:

Allegation One: Violation of RCW 42.17A.235 for failure to accurately and timely report

contributions and expenditures (Public Disclosure Commission form C-4 reports).

Allegation Two: Violation of RCW 42.17A.240 for failure to accurately and timely report debts and

obligations (Public Disclosure Commission form C-4 report and Schedule B).

I am pleased that the Public Disclosure Commission ("PDC") is investigating this issue on behalf of the Attorney General and the county prosecutors, as the expertise of PDC staff with the relevant laws and regulations at issue will be enable them promptly dismiss this case.

My campaign was under no obligation to report any expenditures or contributions because it qualified for "mini reporting" under WAC 390-16-105. I elected mini-reporting when I filed the C1 candidate registration form and my campaign complied with the limitations of this reporting choice (see Exhibit A attached). Because the PDC reporting software, ORCA, is ideal for tracking campaign finance, and because I wanted to carefully track compliance with the mini reporting thresholds, I used the software to manage the campaign books. I uploaded reports like the C4 and C3 as the software prompted. This practice (though not required by law) serves to document my campaign's compliance with the mini-reporting contribution, spending and single donation limits. The complete set of C3 forms in PDC possession shows contributions of \$4,998.87 and expenditures of \$4,847.22 (see Exhibit B attached).


