This correspondence is in response to the complaint filed September 13, 2018 against the Mainstream Republicans of WA State PAC (the PAC) alleging violations of RCW 42.17A. My firm is serving as counsel to the PAC.

RCW 43.17A.320(1) Party Identification

The complaint alleges that party preference was not disclosed for two of three candidates that are the subjects of the mailer referenced in the complaint, specifically Bill Hirt and Patty Kuderer. The mailer in question does in fact disclose that Bill Hirt filed as an independent candidate on both sides of the mailer which satisfies the statute regarding party preference disclosure. The PAC acknowledges the oversight of not disclosing Ms. Kuderer's party preference but notes that the vast majority of the content of the mailer is focused on Rodney Tom whose party preference was properly disclosed.

RCW 42.17A.260(1) Filing Independent Expenditure Reports

The PAC regrets that its compliance team did not receive the information that this mailer was produced until relatively recently. Upon receipt of this complaint from the PDC on Friday, September 14, 2018, the PAC gathered information and filed C-6 reports numbered 8614 and 8615 on Wednesday, September 19, 2018. These reports fully disclose the production and distribution of this mail piece. Please note that these reports were amended on September 27, 2018 to account for an accidental duplicate report (8613) that was subsequently removed, and that those reports are numbered 8624 and 8625, respectively.
